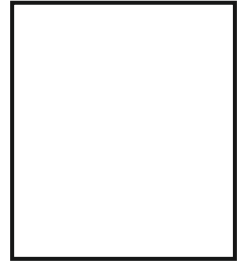

ADMISSION RULES

Enrollment :

Refer course Annexure for more details. At the time of enrollment along with filled registration form, caste and Income certificate, Address Proof & 2 passport size photograph with all testimonials to fulfill the entry qualification requirements.

COURSE FEE :

Fee will be collected by KGTTI from the sponsoring agent for sponsored candidate. The fees structure is subject to change at any time by the institution if situation so demanded. Fee once remitted will not be refunded under any circumstances, no matter the candidate has attended the class or not.

The fee is payable in advance and in case the candidate fails to pay installment of fee, on demand or within stipulated/declared time a fine of Rs. 1000 or 10% the course fee whichever is high will be levied as late fee up to one month, Beyond one month his/her name will be struck off from the rolls and he/she will have to pay re-admission fee Rs. 500/- Re-admission however is not guaranteed. Decision of the Director will be final for granting re-admission.

ATTENDANCE :

The institute expects the participants to maintain full attendance during tenure of the course. However minimum 80% of attendance required for appearing final/module examination. Absence without sufficient cause will lead to automatic expulsion from the course and re admission charges shall be charged Rs 500 or 10% of the course fee whichever is higher.

INTERNAL TEST / ASSIGNMENT :

On completion of each module subject, it is mandatory for all participants to appear for internal test. Minimum expected marks should not be less than 60% in each module for final appearing, held by KGTTI failed participants can reattachment to complete the same assignments - Normally it is mandatory to complete these assignments with 7 days.
